How to ship UN3373 correctly?

The characteristics of the packaging

For the shipment of samples, such as blood, tissues or swab, when they fall under the UN classification "Biological Substance, Category appropriate packaging is needed in accordance with the regulations for dangerous goods.

Biological Substance, Category B requires packaging made of a primary receptacle, a secondary packaging and an outer packaging.

The regulations of dangerous goods require that the UN3373 samples (blood, urine, tissues, ...) are placed in the certified container. Certified must be either primary or secondary container - it must resist an internal pressure of 95 kPa, as required by ADR, RID, ADN, IMDG and ICAO/IATA.

Primary receptacles and secondary packaging must be placed in an outer packaging. The completed package must be able to withstand the drop tests from the height of 1,2 m as required by the P650 ADR (by road), P650 RID (by rail), P650 ADN (by waterway), P650 IMDG (by sea) and P.I. 650 IATA (by air).



The primary receptacle contains the biological sample.



The absorbent material must be in sufficient quantity to absorb any losses. In case of multiple primary packagings, they must be separated from each other.



The secondary packaging must be 95kPa certified (unless the primary one is).



The outer packaging must be of the minimum required dimensions and is provided with an interior support.



The completed package, ready to be shipped, has successfully passed the drop tests from the height of 1,2 m.



Packaging complies with the shipment of Biological Substance Categoy B, UN3373.

How to ship UN2814 and UN2900 correctly?



The characteristics of the packaging

For the shipment of "Infectious Substances, Category A (UN2814 -UN2900)" an UN approved packaging for class 6.2 must be used. The wording "Class 6.2", as required by the regulation, is part of the UN Mark of the approved package. Our packaging for Infectious Substances is UN 4GU certified, this allows to place any type of test tube inside the

Any other certified 4G Class 6.2 packagings (not the 4GU), may be used but only with the specific inner packagings that it has been tested with. To ship in compliance with the different regulations, P620 ADR, P620 RID, P620 ADN, P620 IMDG, P. I. 620 IATA must be followed, according to the chosen shipping method. The regulation for dangerous goods requires that the primary or secondary package **must** resist, without any losses, the inner pressure of 95 kPa and temperature from -40°C to +55°C.
